- Have cell site ready to build on...just need a carrier.
- I am very thankful for the road improvements over the past 10 years. I am concerned about anti-ATV legislation in Lewis County. Thanks for the opportunity to voice my opinions.

- Farm service agency recommends preserving open farm land. Nee to get both snowmobiles and ATV's off plowed roads.
- I have been snowmobiling for about 38 years on Tug Hill and I would like to see the area keep its very rural character. I am a farmer myself in the lower Hudson Valley and I have seen what can happen to the rural character of a town.
- Taxes are very high in the Town of Montague. Somehow they need to try to find money from state/county. Money from snowmobile registration and from ATV registration, they use the roads.
- More enforcement (although not a community or town issue necessarily) against DWI on snowmobiles and ATV's is going to be necessary as the region continues to become busier with traffic. Our party of snowmobilers has totally abandoned the sport due to the greater risks out on the Tug Hill trails the past 5-10 years.

- We understand the need for the trash control. - I live out of state and visit this property only occasionally and do not use the services so checked "no opinion" for these items.
- Make government work for the people, not for special interest or self servicing individuals.
- I will be building a house this spring question #17 is based on the house plans.
- Consolidation of local government and wind power revenue for Montague.
- I feel development is down, causing the tax base to be high in Montague. Driving from Rectors to 177, development starts at the town line. If the tax base could be lowered by consolidating town

governments, then development would increase. The poor conditions of roads are not town roads; they are the county roads. The town does very well with the equipment and amp power they have. The Rector and Gardner roads are prime examples of roads rebuilt and maintained in the last 5 years. The trash problem solution will not help use. We don't lease camp until Sunday evening to drop off trash and head home. Maybe a key to a gated trash area with a charge per key could be considered as we do our road gates. Montague seasonal parking is full every weekend, causing road side parking overnight!

- Property and school taxes are continually increasing. I understand costs always go up, but I see more and more camps and houses going up so you are having a broader tax base. Town services such as road/snow removal and law enforcement basically have stayed the same seeing not many new roads are for seasonal use and thank God the crime rate has not sky-rocketed. Like I said, my land and camp are my get away and I'm glad they are located in the Township of Montague.
- 1)Need to develop cell phone towers in Montague for at least safety reasons, 2)Need to keep up with the roads and repair work, 3)Wind power development in Town of Montague, help with taxes and roads, and 4) Sears Pond, hydro power?
- I like the peace and calmness Tug Hill has. I also greet the challenge one must experience from season to season.
- I would like to see studs on snowmobiles outlawed. They are major tire hazards on all types of vehicles from ATV's to logging trucks. They all tear up blacktop!
- We believe snowmobiling could be made safer by making connecting trails along the side of the road as was done on Factory/McDonald this past winter; or creating trails just beyond the snow banks. It is our hope that in the future, state lands will be utilized more for trails, which would take a great deal of pressure off the need for landowner usage which causes problems when riders are disrespectful and then snowmobiling gets a bad name and trails are closed. Also, opening up state land would create a larger arena for riding each time a trail is closed it forces many more machines to run in more congested areas which increases the chances of accidents. We agree that ATV trails should be made available. We are not opposed to using town roads for this purpose but something should be done to the road surface near residences and businesses to control the dust problem in the summer. We are not able to sit outside on our property because of the dust on a busy day.

We are concerned about the continued wind farm development which will destroy the aesthetic beauty of the Tug Hill Region.

In Re: #16, we feel that within the Tug Hill Commission's jurisdiction zoning and code enforcement laws should be the same in each township.

If all of us are going to keep the beautiful pristine wilderness that Tug Hill is, we believe County government is going to have to offer dollars to help local townships keep the open quality and not look to future land and business development to bail them out financially.

We believe there should be a concentrated effort for increased state ownership in order to keep development of any kind out of this fragile area. We have visited just about every area of NYS and the Tug Hill region is one of the last frontiers of untouched land in regard to major development. We might add that we favor the state land being used for a variety of sport-related uses. We realize more state land means higher taxes but this generation owes it to future generations to save some open space for all to enjoy. Please don't join the phobia which now exists in south-eastern NYS where the urge seems to be to put a building on every ½ acre. This action is destroying what once was a beautiful area full of flourishing farms, green pastures and stately forests!

• My children will be 4th generation property caretakers. I hope that Montague can remain as wild and natural as possible. 5-6 generations ago, it was developed around the lumber and farming

industries. I'm afraid that the new people coming in may not respect nature as much; they seem often to just visit, abandon all limits, abuse the neighborhood, and then complain. I wish to express my gratitude to all that are giving consideration to what's best for the area. I think development of the Sears Pond area would be enjoyed if the right amount of regulation, planning and enforcement were exercised. Best of Luck and Wisdom. P.S. I hope the restriction on garbage disposal at the town barn doesn't cause a lot of roadside dumping. That weekly mountain of trash is going to go somewhere.

Please do not commercialize this area. Stop ATV abuse in road ways and parking areas. Open logging roads on state and county land, keeping them off public access right-of-way. The property owners access to their property should not be abused or limited. Reckless use on public access, and abuse of property should be stopped. Damage to vehicles in parking area by doing donuts, etc, (ATV and snowmobiles) happens frequently. Excess speed throws gravel onto vehicles and creates excessive dust (impossible to see anything) or keep property clean. Can you have outdoor laundry stay clean or picnic table while eating? Excessive noise from altered exhaust on recreational vehicles is abusive and offensive - not enjoyable to all. Property owner's vehicles cost money too, how about helping us keep them and us safe. We came here to enjoy being away from all of the noise and aggravation. Please respect our rights also. Snowmobiling and ATV use should be enjoyable to property owners, as it used to be and to those whom respect the use of same. Opening up the area to excessive use is not a viable use. The roadways are not mud bogs - speedways or snow pro raceways. Most roadways are not safely usable at speeds over 25 to 30 mps as is. How many chopper landings and deaths does it take for people to realize this? If snowmobiling use is restricted as in the Old Forge area, it is and can be very enjoyable. ATV use as in ATV only trails, out west and in Pennsylvania is also enjoyable, they are all separate from public access roadway, also in Canada.

NYS mandates registration and insurance on all ATV and Snowmobiles, the same as automobile usage. They use this money for roadways public access to private property and community usage. Now why can't the NYS provide trails for snowmobiles and ATV usage. They say they raised registration fees to do just that not the slush fund for NY city, etc.

ATV and snowmobile usage does not mix with automobile, hiking, skiing, horse trails, etc. They need to use the registration money for separate trails and or roadways as they promised to use that money for just that purpose. Why continue to compromise the property owners privacy and peacefulness, safety, etc., it's only an inconvenience for all of us.

- One of the reasons we decided to buy a place/property in Lewis County was for the use of snowmobiles and ATV's. Over the last few years there have been changes that have made it very difficult for us to ride our snowmobiles and ATV's in the area surrounding our property. I feel that "land-owners" should be granted a variance or given a pass that allows us to ride on these "closed" roads. Our property is within ¼ miles of the trail on Liberty Road. Should we have to trailer our snowmobiles or ATV's to the trail when we are just down the road?
- We appreciate what you are attempting to do. Survey is a great idea, even a stamped envelope WOW!
- In June 2004, we purchased a camp that was unfinished on the Pitcher Road in the Town of Montague. We have since finished remodeling the inside of our camp and have had it hard wired for electricity with the intent of having electricity on our road in the near future.

During the 2004 and 2005 years, I had several telephone conversations with Mr. Buzzell (who was the Pitcher Road planning representative for Niagara Mohawk) explaining to him that several of the land owners on the Pitcher Road had interest in electric hookups. Mr. Buzzell told me that each land owner had to sign a land easement before Niagara Mohawk could consider the planning of the

electric poles. I immediately wrote letters to each of the land owners explaining what must be done on their part to proceed with this project. Most of the landowners called me, or wrote a letter, saying they had filed their easements. In the spring of 2005, Mr. Buzzell called my office requesting that my husband and I meet him at our camp to assist him with marking the land owner's territory lines so that he could place the electric pole markers. Accordingly, my husband and I took time off from our jobs to do this.

The next time I spoke with Mr. Buzzell, he told me that Niagara Mohawk (now National Grid) would not furnish electricity on the Pitcher Road unless each land owner that was interested in having the electric paid approximately \$12,000 to \$30,000 (depending on their camp's location on the Pitcher Road). He proceeded to explain that Niagara Mohawk furnishes the first 500 feet free and any distance after that the land owner has to pay.

We do not understand how the land owners on the Gardner Road could get electric power hookups as, in some cases, the electric poles are placed more than 500 feet through vacant lots in between camps.

We are wondering why it is so difficult to get eclectic power on the Pitcher Road when there is eclectic on the Sears Pond Road with an eclectic pole where the Sears Pond Road meets the Pitcher Road. Our camp is located exactly ½ mile from that electric pole.

We have the Maple Ridge Wind Farm furnishing raw power to the New York City area, but we can't get electric ½ mile to our camp?!! Having electric on the Pitcher Road would also increase the value of the property. All of the land owners' taxes have increased, and in some cases, more than doubled within the past year. We do not understand why this has happened since nothing has changed nor have any improvements been made to increase land value along the Pitcher Road.

Is it possible for the Town of Montague to help us with this issue between National Grid and the land owners, or can you refer us to someone who can help? I would appreciate your assistance in this matter. Thank you. Linda and Terry Noftsier.

• As a concerned Town of Montague tax payer, I offer the following observations and suggestions regarding the changes to the town's efforts to promote proper waste collection and removal.

Observations: It appears that the locals, campers and visitors are making an effort to keep the town trash free by using the dumpster provided by the town. With the growth, I assume in the numbers of new camps and recreational vehicles, this is a normal increase in trash and garbage. The dumpster is a better place than on the side of the roads or in secluded locations. It is my belief that this condition will only increase as the town grows. The rebuilding and development of the Sears Pond area will only make this condition worse. My feeling is to oppose the Sears Pond development as it will only increase my taxes. I have not heard any proposals to address the policing, trash collection and disposal for this development. This will also, in my view, increase the trash coming into Montague requiring more manpower to support this effort. To me, this translates into a higher tax burden for only the locals to carry. The local businesses will just pass it on to their customers. The limiting of dumpster use and the threat of criminal prosecution will, in my view, just exacerbate the garbage and trash problem. The message being sent – this is not a friendly town to visit. Also, who will be paid to work at the town barn on Sunday to monitor the dumpster?

Recommendations: My recommendations would be to provide two dumpsters plainly labeled one for garbage and the other for debris. It would be announced by the town communicating a code of conduct/ordinance suggesting to all residents, camp owners, weekend campers and tourists to use the

recommended dump site as a good neighbor message that will help keep Montague clean and a good place to visit and enjoy. Town signs could be placed at the entrance and exits that provide positive reinforcements to keeping Montague clean. Also, a monitoring system of video cameras equipped with night vision and motion detection could be installed for prosecution purposes at the dumpsters. This would be more cost effective than having the road crews cleaning up and disposing of the garbage and waste that will end up on our town roads and secluded locations. The old saying, "you will catch more flies with honey than with vinegar," fits this situation.

A closing question – what are Harrisburg, Martinsburg and Pinckney going with regards to this specific problem? How successful are they and what has it cost them?
